Subject: Inviting Applications for Financial/Aid Assistance (Session 2025—26)

Due to low response to the notice No. GCET/25/Adm./1728-33 dated 27.10.2025 and No. GCET/25/Adm/1815-20 dated 18.11.2025 regarding the subject cited above, the last date has been extended upto 30.01.2026 for receiving applications from the interested eligible students of the following categories of this Institution for seeking **Financial Assistance out of Students Aid Fund during the session 2025-26:-**

- A** Orphan students with no source of income/ Children from broken families having no economic support to continue their studies.
- B** Physically challenged/handicapped students/students suffering from chronic diseases and dependent on lifelong medical support. This also includes students having a handicapped father with small earnings.
- C** EWS/AYY category students belonging to the Economically Weaker Section (EWS) or Antyodaya Anna Yojana (AAY).

The applications complete in all respects should reach the **Office of the Registrar, GCET Jammu, on or before 30th January, 2026 (up to 4:00 PM)** along with documentary proof of eligibility for Financial Aid 2025-26.


Documents (Certificates to be Attached)

Students applying under the above-mentioned categories must attach **self-attested** copies of the following verified documents in support of their claim:

1. **Latest Income Certificate** from the concerned Tehsildar/Executive Magistrate (for non-government employees) with a monthly ceiling of up to 10,000/- (For Categories A, B & C)
2. **Medical Certificate** in respect of physically challenged persons issued by the Medical Board (percentage of disability should be above 40%). (For Category B)
3. **Undertaking/Affidavit** stating that no financial assistance is being availed from any other scheme, duly attested by the concerned Executive/Judicial Magistrate. (For Categories A, B & C)
4. **Death Certificate** and affidavit in case of the demise of the earning parent(s). (For Category A)
5. **Divorce Certificate/Court Order** in case of children from broken families, along with proof that the applicant resides with the non-earning parent. (For Category A)
6. **EWS/AYY Ration card.** (For Category C)
7. **Copy of Aadhar Card.**
8. **Bank Account details** (Photo copy of bank passbook showing Account Number and IFSC code).
9. **Marks Card** of the previous semester.

Important to note:

1. Students already availing benefits under any other scholarship/financial aid scheme are **not eligible** to apply.
2. All photocopies of documents submitted must be self-attested.
